Aspire's mission is to support the successes of children and adults with developmental disabilities, strengthen their families and build embracing communities.

Aspire Living provides housing options that assist adults with disabilities to live as independently as possible in the community and Life Enrichment services that further promote interaction with their communities. 125 individuals currently reside in our community homes, shared and intermittent living facilities and participate in our Life Enrichment program. Aspire's Life On My Own program empowers adults with mild to moderate developmental disabilities to transition to living independently in the community with minimal assistance. To date, 45 adults with disabilities have worked toward achieving the skills and confidence necessary for independent living. Of them, 30 continue to live independently with very minimal assistance.

4b (Code: ) (Expenses \$ 1,398,514. including grants of \$ ) (Revenue \$ 368,943.)
Aspire Kids is a leading provider of pediatric therapy as well as school and community inclusion services for children with disabilities and their families. In FY18, Aspire served 711 children with disabilities through pediatric therapy services. Through the "All Are Welcome" initiative, Aspire and our partners have measurably impacted the lives of 369 students with disabilities and 5,231 of their typically-developing peers, 518 education professionals and 406 parents at 30 Catholic schools in Chicago and its suburbs. Over the past two years, more than 90 children with developmental disabilities were newly enrolled across the schools.

Aspire Careers helps adults with disabilities to experience the independence and pride that accompanies workplace inclusion and gainful employment. Since the launch of the Harry and Jeanette Weinberg Career Academy in 2017, 105 people have participated in the Academy and 16 individuals have secured community-based jobs earning well over minimum wage.
